Resolution adopted by the Human Rights Council

Technical assistance for the Sudan in the field of human rights

The Human Rights Council,

Guided by the principles and objectives of the Charter of the United Nations, the Universal Declaration of Human Rights and other relevant instruments,

Reaffirming the obligation of States to promote and protect human rights and fundamental freedoms,

Emphasizing that States have the primary responsibility for the promotion and protection of all human rights,

Recognizing the developments taking place in the Sudan, and the record of the Government of the Sudan in the promotion and protection of human rights,

Noting with concern the human rights abuses by all parties, in Darfur, Southern Kordofan and Blue Nile region,

Reaffirming the Human Rights Council's resolution 18/16 dated 14 October 2011,

1. *Takes note* of the report of the Independent Expert to Sudan and the addenda thereto, submitted to the Council at its 21st session;
2. *Expresses* its appreciation to the Independent Expert for his work and the recommendations he made;
3. *Notes that the Independent Expert commended* the cooperation extended by the Government of the Sudan to him during his last visit to the country;
4. *Welcomes* the commitment by the Government of the Sudan to resolve the outstanding issues with the Government of South Sudan;
5. *Welcomes* the Memorandum of Understanding between the Government of the Sudan and the Tripartite Partners (United Nations, Arab League and African Union) for the Assessment and Delivery of Humanitarian Assistance to war-affected civilians in South Kordofan and Blue Nile States;
6. *Notes* the need for the positive commitment of all stakeholders to the effective implementation of the Doha Document for Peace in Darfur, particularly the chapters

- on human rights and fundamental freedoms, and on justice and reconciliation, and urges non signatory groups to join it without delay;
7. *Welcomes* the continued work of the Sudanese Advisory Council on Human Rights aimed at the promotion and protection of human rights in the country;
 8. *Welcomes* the establishment of the National Human Rights Commission as an independent mechanism for promotion and protection of human rights in the Sudan;
 9. *Welcomes* the submission by the Government of the Sudan of its first UPR report, and *acknowledges* the steps taken by the Government to implement the accepted recommendations as highlighted in the Independent Expert's report, and notes the need to specify time frames for the implementation strategies;
 10. *Requests* the Independent Expert to assist the Government in its strategy to implement the remaining recommendations;
 11. *Urges* the Government of Sudan to rebuild a lasting climate of confidence and trust with civil society organizations and the international community, and to facilitate the promotion and protection of human rights in the country;
 12. *Urges* Member States, relevant United Nations agencies and stakeholders to support the national efforts of the Government of the Sudan as per the Council's resolution 18/16 with a view to further improving the human rights situation in the country, and to respond to its requests for technical assistance;
 13. *Notes with concern* the humanitarian situation in the provinces of South Kordofan and Blue Nile, and calls upon all parties to make every effort to immediately end violence and halt clashes, to facilitate access for humanitarian assistance and to take action to strengthen the respect of the rule of law in the two provinces, and to respect all human rights and fundamental freedoms;
 14. *Requests* the Office of the United Nations High Commissioner for Human Rights to provide Sudan with the necessary technical support and training;
 15. *Urges* the Government of the Sudan to continue its cooperation with the Independent Expert, including giving him access to all the country in particular in Darfur, Blue Nile and Southern Kordofan; in order to assess and verify the state of human rights, to determine the technical assistance needs, and to report on his findings;
 16. *Decides* to renew for a period of one year the mandate of the Independent Expert to the Sudan under Agenda item 10, requests the Independent Expert to continue his engagement with the Government of the Sudan with a view to implementing the projects that will further help Sudan to fulfill its human rights obligations, and to submit a report to the Human Rights Council for consideration at its twenty fourth session;
 17. *Decides* to continue considering this issue in accordance with its Program of Work under Agenda item 10.
