I. INTRODUCTION

1. The Registry hereby transmits to the Appeals Chamber (“Chamber”), a “*Request to Disqualify the Prosecutor and for Ancillary Remedies*”, (“Request”) and its annexes, received from the State of Israel (“Submitter”), on 17 November 2025.

II. PROCEDURAL HISTORY

2. On 17 November 2025, the Registry received an e-mail from the Embassy of Israel, with three documents attached, consisting of the Request and two annexes.¹
3. On the same day, the Registry consulted the Chamber to seek guidance on whether and how to place the Request on the case record.²
4. On 18 November 2025, the Chamber instructed the Registry to submit the Request *via* a Registry transmission filing (“Instruction”).³


