## A BILL

To amend the Foreign Assistance Act of 1961 to limit assistance to the Palestinian Authority and the Palestine Liberation Organization, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No Bonuses for Ter-  
5 rorists Act”.

1 **SEC. 2. LIMITATIONS ON ASSISTANCE TO THE PALESTINIAN**  
2 **AUTHORITY AND THE PALESTINE LIBERA-**  
3 **TION ORGANIZATION.**

4 Chapter 1 of part III of the Foreign Assistance Act  
5 of 1961 (22 U.S.C. 2351 et seq.) is amended by adding  
6 at the end the following new section:

7 **“SEC. 620N. LIMITATIONS ON ASSISTANCE TO THE PALES-**  
8 **TINIAN AUTHORITY AND THE PALESTINE LIB-**  
9 **ERATION ORGANIZATION.**

10 “(a) LIMITATIONS.—

11 “(1) PALESTINIAN AUTHORITY.—In addition to  
12 the limitation on assistance to the Palestinian Au-  
13 thority described in sections 620K and 620L, assist-  
14 ance may be provided under this Act to the Pales-  
15 tinian Authority only during a period for which a  
16 certification described in subsection (b) is in effect.

17 “(2) PALESTINE LIBERATION ORGANIZATION.—  
18 Assistance may be provided under this Act to the  
19 Palestine Liberation Organization only during a pe-  
20 riod for which a certification described in subsection  
21 (b) is in effect.

22 “(b) CERTIFICATION.—A certification described in  
23 paragraphs (1) and (2) of subsection (a) is a certification  
24 submitted by the Secretary of State to Congress that con-  
25 tains a determination of the Secretary that the Palestinian  
26 Authority, including any ministry, agency, or instrumen-

1 tality or any official acting on behalf of any such ministry,  
2 agency, or instrumentality, and the Palestine Liberation  
3 Organization, as the case may be, has ceased the payment  
4 of any bonuses, financial compensation, or any other ben-  
5 efit not generally or otherwise available to the Palestinian  
6 population at large to the families of Palestinians killed  
7 in connection with—

8           “(1) conspiring to commit an act of terrorism;

9           or

10           “(2) the commission of an act of terrorism.

11           “(c) RECERTIFICATIONS.—Not later than 90 days  
12 after the date on which the Secretary of State submits  
13 to Congress an initial certification under subsection (b)  
14 and every six months thereafter—

15           “(1) the Secretary shall submit to Congress a  
16 recertification that the conditions described in sub-  
17 section (b) are continuing to be met; or

18           “(2) if the Secretary is unable to make such a  
19 recertification, the Secretary shall submit to Con-  
20 gress a report that contains the reasons therefor.

21           “(d) CONGRESSIONAL NOTIFICATION.—Assistance  
22 made available under this Act to the Palestinian Authority  
23 or the Palestine Liberation Organization may not be pro-  
24 vided until 15 days after the date on which the Secretary  
25 of State has provided notice thereof to the appropriate

1 congressional committees in accordance with the proce-  
2 dures applicable to reprogramming notifications under  
3 section 634A(a).

4 “(e) AVAILABILITY OF FUNDS FOR IRON DOME.—If  
5 the Secretary of State is unable to submit a certification  
6 to Congress under subsection (b) or a recertification under  
7 subsection (c), funds made available under this Act for  
8 assistance to the Palestinian Authority and the Palestine  
9 Liberation Organization that otherwise would have been  
10 provided to the Palestinian Authority and the Palestine  
11 Liberation Organization shall, notwithstanding any other  
12 provision of law, be transferred and made available to the  
13 Secretary of Defense to provide assistance to the Govern-  
14 ment of Israel for the procurement of the Iron Dome de-  
15 fense system to counter short-range rocket threats.

16 “(f) ANNUAL REPORTS.—The Secretary of State  
17 shall annually submit to the appropriate congressional  
18 committees a report on the amount of any bonuses, finan-  
19 cial compensation, or any other benefit described in sub-  
20 section (b) that have been disbursed by the Palestinian  
21 Authority, including by any ministry, agency, or instru-  
22 mentality or any official acting on behalf of any such min-  
23 istry, agency, or instrumentality, and the Palestine Lib-  
24 eration Organization in the preceding 12-month period.

25 “(g) DEFINITIONS.—In this section:

1           “(1) ACT OF TERRORISM.—The term ‘act of  
2 terrorism’ means an act dangerous to human life  
3 that would violate the criminal laws of the United  
4 States if committed within the jurisdiction of the  
5 United States that appears to be intended to—

6           “(A) intimidate or coerce a civilian popu-  
7 lation;

8           “(B) influence the policy of a government  
9 by intimidation or coercion;

10           “(C) affect the conduct of a government by  
11 mass destruction, assassination, or kidnapping;  
12 or

13           “(D) impair Israel’s existence as a Jewish,  
14 democratic state within its current territorial  
15 boundaries.

16           “(2) APPROPRIATE CONGRESSIONAL COMMIT-  
17 TEES.—The term ‘appropriate congressional com-  
18 mittees’ means—

19           “(A) the Committee on Foreign Affairs  
20 and the Committee on Appropriations of the  
21 House of Representatives; and

22           “(B) the Committee on Foreign Relations  
23 and the Committee on Appropriations of the  
24 Senate.

1           “(3) FOREIGN TERRORIST ORGANIZATION.—  
2           The term ‘foreign terrorist organization’ means an  
3           organization designated as a foreign terrorist organi-  
4           zation by the Secretary of State in accordance with  
5           section 219(a) of the Immigration and Nationality  
6           Act (8 U.S.C. 1189(a)).

7           “(4) PALESTINIAN AUTHORITY.—The term  
8           ‘Palestinian Authority’ means the interim Pales-  
9           tinian administrative organization that governs part  
10          of the West Bank and all of the Gaza Strip (or any  
11          successor Palestinian governing entity), including  
12          the Palestinian Legislative Council.”.
