### **Opening for signature**

The Arms Trade Treaty was adopted by the General Assembly in its resolution 67/234B of 2 April 2013.

In accordance with its article 21, the Treaty shall be open for signature at the United Nations Headquarters in New York by all States from Monday, 3 June 2013, until its entry into force.

Certified true copies of the Treaty, of which the Arabic, Chinese, English, French, Russian and Spanish texts are equally authentic, are under preparation. Electronic copies of the Treaty will be made available soon on the United Nations Treaty Collection website ([click here](#)).

The Secretary-General takes this opportunity to recall that, under established international practice, only Heads of State, Heads of Government or Ministers for Foreign Affairs are empowered, by virtue of their functions, to sign treaties on behalf of States without having to produce full powers to that effect. Other representatives wishing to sign the Treaty must be in possession of appropriate full powers emanating from one of these authorities.

The Secretary-General would be obliged if States wishing to sign the Treaty could, as necessary, provide the required full powers in advance to the Treaty Section, Office of Legal Affairs, United Nations Headquarters (fax 1 (212) 963-3693).
