ORAL STATEMENT BY THE SECRETARIAT IN CONNECTION WITH DRAFT RESOLUTION A/HRC/52/L.43 ENTITLED "HUMAN RIGHTS SITUATION IN THE OCCUPIED PALESTINIAN TERRITORY, INCLUDING EAST JERUSALEM, AND THE OBLIGATION TO ENSURE ACCOUNTABILITY AND JUSTICE".

1. This statement is made in accordance with rule 153 of the Rules of procedure of the General Assembly.

2. Under the terms of operative paragraph 27 of draft resolution A/HRC/52/L.43, the Human Rights Council would:

(a) Also request the United Nations High Commissioner for Human Rights to report on the implementation of the present resolution to the Human Rights Council at its fifty-fifth session, to be followed by an interactive dialogue (OP. 27).

3. In order to implement the mandate contained in paragraph 27 of the draft resolution, the following activities and resources would be required in 2024:

(a) Conference services for the report to be submitted to the Human Rights Council at its fifty-fifth session, to be followed by an interactive dialogue.

4. The activities referred to above relate to section 2, General Assembly and Economic and Social Council affairs and conference management of the programme budget for 2024.

5. The adoption of the draft resolution A/HRC/52/L.43 would give rise to total non-recurrent requirements of \$23,400 as follows:

General on the revised estimates resulting from resolutions and decisions adopted by the Human Rights Council during 2023.
