STATEMENT OF PERMANENT REPRESENTATIVE OF SUDAN MISSION IN RESPONSE TO 9TH SESSION DELIBERATION ON HUMAN RIGHTS SITUATION IN SUDAN

Mr. President,

When this Session started, my delegation was so much thrilled that my Country's efforts and co-operation with World Community particularly the Human Rights organs will be recognized and applauded. To the contrary, the European Union and the Special Rapporteur have tarnished Sudan's image due to their hostile agenda towards Sudan

Nevertheless, we are heightened by encouraged statements several groups and delegations that have deeply acknowledged the cooperation of the Government of National Unity and all other levels of government including the Government of Southern Sudan with noticeable human rights improvements. The Sudanese delegation and the Government of National Unity sincerely thank the African Group for their vigilance, objectivity and commitment to assisting Sudan in all aspect of resolution of the ''Darfur'' crisis.

We also thank the Arab League and its delegation for their support and dedication to resolve the tragedy in Dafur. Our Arab brothers and sisters and their governments have been along our side in good and bad situations. We acknowledge and appreciate their efforts to tell the Council the truth about Sudan.

The Organization of Islamic Conference efforts and objectivity has illuminated the facts, and efforts of the Government of National Unity to achieve peace and stability. We are also thankful to several countries particularly China, Cuba, Latin

Americans, Asians who do have no hostile agenda against Sudan. For the sake of all those mentioned above, Sudan will be a diligent participant in Human Rights Council, with the help of objective members and observers country, we hope the current hijacking of HRC by EU and using the HRC as an instrument of weakening or overthrowing governments they do not want; will be stopped.

Mr. President,

The Special Rappoteur on Sudan, Miss Sima Samar, has demonstrated that she is an agent of European Union rather than the Universal Human Rights Council Rapporteur. She is the catalyst planned to trigger the justification for the EU to slash the modest achievements of Sudan in its determination to restore decent human rights in war affected zone of Darfur.

Mr. President,

For the Special Rapporteur to say the situation of human rights in the entire country is bleak is demonstration of her bias attitude towards Sudan. If Sudan is totally devoid of human rights then how can she fly into Sudan, and travel to several cities safe, and enjoying good sleep in hotels and even visits with prisoners; one whom she says murdered a student in Nielen University? Why has she been selective of people and organizations she met? If Sudan is in anarchy, would it be possible for her to travel safely? Let Sima Samar do report on Afghanistan whether she will travel on any other roads or in Iraq if she will ever get out of the green zone.

Mr. President,

EU in collaboration with such reporters demonstrates one aspect of threat to credibility of HRC. This organization needs to be protected by ethical standard and high moral ground if it is to

continue to attract loyalty of members and observers countries. The European Union wants to use this body as a means to recolonize the countries that fought their colonial reign. We have not forgotten what France has done in Algeria, Vietnam and inhumane treatment in colonies in recent past. The world is aware of bleak lives of immigrants in Germany and the upcoming anti-Islamic Organization in Cologne. Western Ideology of being masters of the world is not compatible with the values of human rights council. Spinning the truth and utilizing media to mask the truth must be repudiated by this Council.

Now that, Africans who are truly champions of human rights are at the helm of the leadership of Human Rights Council, and its institutions. This is the time to be vigilant with colonialist that characterize France, United Kingdom and their associates.

Mr. President,

Sudan in on track, fulfilling all its obligations towards enhancing human rights in the entire Sudan and particularly in pockets of Rebel infested areas in Darfur. The issue of human rights in these pockets is the rebellion. The rebels are those who attack civilians, ambush peace keepers, hijack food being delivered to internally displaced persons and frequently attack government posts and installations.

The leadership of these rebels are harbored by France and her surrogate colonies. France talks of human rights, while it accommodates those who terrorize innocent people in Darfur. It talks of impunity, but those who rape woman, kill peacekeepers they accommodate in five stars hotel in Paris. They even make them travel to United States for recreation and planning for their destructive plots.

Mr. President,

Sudan Delegation urge the leadership of HRC to restore credibility to the organization as Miss Navi Pally said in her address to the Council. Sudan has taken credible steps to emerge out war, it has made durable peace in South and East. In case of Darfur peace, France and United States were partners in reaching Abuja Peace with rebels. They were the architect of UN resolution 1679 which demanded that Darfur Rebels sign peace within 90 days albeit they be considered terrorist. Instead of enforcing this UN resolution, France accommodates and harbors these rebels leaders and promote their agenda of over throwing the Government that has championed peace. The GONU is not what the meida call Northern Arab dominated Government of Omer Bashir but a true coalition of champions of peace the Sudan Peoples Liberation Movement, the Northern parties, the Southern parties and National Congress Party.

These partners are dedicated to transforming Sudan into a legitimate democracy. It has followed incredible steps of transformation. By next year Sudan will be governed by freely elected individuals from over 40 parties. This is what the west and particularly EU do not want to happen.

Yet with the help of our African friendly union, the Arab League and countries against domination and recolonization, Sudan will prevail.

What Sudan needs is for International community to convince the rebels in Darfur to accept dialogue and of the current insurgency that has jeopardize the human rights situations in UN and the invigoration of UNAMID so that peace and stability returns to Darfur. The rest of Sudan is marvelous. There are no

human rights problem in Southern Sudan, Northern Sudan, Eastern Sudan and Central Sudan.

These regions are enjoying the dividends of peace. The economy is booming with unprecedented growth rate. The refugees are returning at rate that exceed the capacity of absorbing them into community. This is an indication of approval pf what the Government is doing.

We offer Sima Samar 90 days continuous stay in Sudan and she will acknowledge, that Sudanese are the best people in the world and she will regret her bias, politically motivated report.
