I. INTRODUCTION

1. The Registry hereby transmits to the Appeals Chamber (“Chamber”), a *“Joint Victims’ Request to submit Observations in the appeal against the « Decision on Israel’s request for an order to the Prosecution to give an Article 18(1) notice » of 21 November 2024”* (the “Request”) received on 15 July 2025 from Raji Sourani, Chantal Meloni, Triestino Mariniello, Rodney Dixon KC, Jeanne Sulzer and Clémence Witt (“Submitters”) titled *“Joint Victims’ Request to submit Observations in the appeal against the « Decision on Israel’s request for an order to the Prosecution to give an Article 18(1) notice » of 21 November 2024”*.

II. PROCEDURAL HISTORY

2. On 15 July 2025, the Registry received an e-mail from Raji Sourani, Chantal Meloni, Triestino Mariniello, Rodney Dixon KC, Jeanne Sulzer and Clémence Witt, with one document attached containing the Request.¹
