I. INTRODUCTION

1. The Registry hereby transmits to the Appeals Chamber (“Chamber”), a document titled *“Requête de représentants légaux de victimes de soumettre des observations dans le cadre de l’appel contre la “Decision on Israel’s request for an order to the Prosecution to give an Article 18(1) notice” (ICC-01/18-375)”* (“Request”) received on 21 July 2025 from Khaled Al Shouli, Dominique Cochain and Julie Goffin (“Submitters”).
