Programme budget implications relating to the programme budget for 2021

A. Problems arising from the accumulation of conventional ammunition stockpiles in surplus

Programme budget implications of draft decision [A/C.1/75/L.67](#)

The Fifth Committee, having considered the statement of programme budget implications submitted by the Secretary-General¹ and the related report of the Advisory Committee on Administrative and Budgetary Questions,² decides to inform the General Assembly that, should it adopt draft decision [A/C.1/75/L.67](#), additional resources amounting to 286,900 United States dollars would be required for 2021, comprising 85,000 dollars under section 2, General Assembly and Economic and Social Council affairs and conference management, 198,400 dollars under section 4, Disarmament, and 3,500 dollars under section 29E, Administration, Geneva, of the proposed programme budget for 2021, representing a charge against the contingency fund.

B. The illicit trade in small arms and light weapons in all its aspects

The Fifth Committee, having considered the statement of programme budget implications submitted by the Secretary-General³ and the related report of the Advisory Committee on Administrative and Budgetary Questions,⁴ decides to inform the General Assembly that, should it adopt draft resolution [A/C.1/75/L.44](#), additional resources amounting to 203,100 United States dollars would be required for 2021

C. Developments in the field of information and telecommunications in the context of international security

Programme budget implications of draft resolution

The Fifth Committee, having considered the statement of programme budget implications submitted by the Secretary-General⁵ and the related report of the Advisory Committee on Administrative and Budgetary Questions,⁶ decides to inform the General Assembly that, should it adopt draft resolution [A/C.1/75/L.8/Rev.1](#), additional resources amounting to 269,900 United States dollars would be required for 2021, comprising 241,800 dollars under section 2, General Assembly and Economic and Social Council affairs and conference management, 25,100 dollars under section 4, Disarmament, and 3,000 dollars under section 28, Global communications, of the proposed programme budget for 2021, representing a charge against the contingency fund.

D. Open-ended Working Group on Developments in the Field of Information and Telecommunications in the Context of International Security established pursuant to General Assembly resolution [73/27](#) of 5 December 2018

Programme budget implications of draft decision [A/C.1/75/L.47](#)

The Fifth Committee, having considered the statement of programme budget implications submitted by the Secretary-General⁷ and the related report of the Advisory Committee on Administrative and Budgetary Questions,⁸ decides to inform the General Assembly that, should it adopt draft decision [A/C.1/75/L.47](#), additional resources amounting to 187,500 United States dollars would be required for 2021, comprising 168,700 dollars under section 2, General Assembly and Economic and Social Council affairs and conference management, and 18,800 dollars under section 4, Disarmament, of the proposed programme budget for 2021, representing a charge against the contingency fund.

E. Group of Governmental Experts on Advancing Responsible State Behaviour in Cyberspace in the Context of International Security established pursuant to General Assembly resolution [73/266](#) of 22 December 2018

The Fifth Committee, having considered the statement of programme budget implications submitted by the Secretary-General⁹ and the related report of the

Advisory Committee on Administrative and Budgetary Questions,¹⁰ decides to inform the General Assembly that, should it adopt draft decision [A/C.1/75/L.60](#), additional resources amounting to 366,600 United States dollars would be required for 2021, comprising 176,600 dollars under section 2, General Assembly and Economic and Social Council affairs and conference management, and 190,000 dollars under section 4, Disarmament, of the proposed programme budget for 2021, representing a charge against the contingency fund.

F. Situation of human rights of Rohingya Muslims and other minorities in Myanmar

Programme budget implications of draft resolution [A/C.3/75/L.34](#)

The Fifth Committee, having considered the statement of programme budget implications submitted by the Secretary-General¹¹ and the related report of the Advisory Committee on Administrative and Budgetary Questions,¹² decides to inform the General Assembly that, should it adopt draft resolution [A/C.3/75/L.34](#), resources amounting to 1,152,600 United States dollars, net of staff assessment, would be required for 2021 for the continuation of the Office of the Special Envoy of the Secretary-General on Myanmar; approval of those requirements is sought in the context of the proposed programme budget for 2021 for special political missions under section 3, Political affairs.

G. A global call for concrete action for the elimination of racism, racial discrimination, xenophobia and related intolerance and the comprehensive implementation of and follow-up to the Durban Declaration and Programme of Action

Programme budget implications of draft resolution [A/C.3/75/L.50/Rev.1](#)

The Fifth Committee, having considered the statement of programme budget implications submitted by the Secretary-General¹³ and the related report of the Advisory Committee on Administrative and Budgetary Questions,¹⁴ decides to inform the General Assembly that, should it adopt draft resolution [A/C.3/75/L.50/Rev.1](#), additional resources amounting to 262,300 United States dollars would be required for 2021, comprising 23,300 dollars under section 24, Human rights, and 239,000 dollars under section 28, Global communications, of the proposed programme budget for 2021, representing a charge against the contingency fund, together with an amount of 600 dollars under section 36, Staff assessment, to be offset by an equivalent amount under income section 1, Income from staff assessment.

H. Oceans and the law of the sea

Programme budget implications of draft resolution [A/75/L.39](#)

The Fifth Committee, having considered the statement of programme budget implications submitted by the Secretary-General¹⁵ and the related report of the Advisory Committee on Administrative and Budgetary Questions,¹⁶ decides to inform the General Assembly that the adoption of draft resolution [A/75/L.39](#) would give rise to the following:

(a) Approval of the establishment of one new temporary post (P-2) in 2021, and the extension of two temporary posts (1 P-3 and 1 General Service (Other level)) from 2020, under section 8, Legal affairs, of the proposed programme budget for 2021, effective 1 January 2021;

(b) Additional resources amounting to 1,208,100 United States dollars would be required for 2021, comprising 623,900 dollars under section 2, General Assembly and Economic and Social Council affairs and conference management, and 584,200 dollars under section 8, Legal affairs, of the proposed programme budget for 2021, representing a charge against the contingency fund, together with an amount of 119,900 dollars under section 36, Staff assessment, to be offset by an equivalent amount under income section 1, Income from staff assessment.
