	well. The 2007 Paris "Principles and Guidelines on
	Children Associated with Armed Forces or Armed
	Groups"11 define a "child soldier" as any person below
	the age of 18 who has been recruited or used by an
	armed group in any capacity, not just a child who has
	arried broup in arry capacity, not just a crima who has

taken direct action in hostilities. By this internationally accepted definition, Palestinian children in Hamas' summer camps and those brainwashed by armed groups through other media, all fit into the category of "child soldiers." Both the use of child soldiers and the indoctrination of youth by Hamas <u>violate international</u> <u>human rights laws</u>, including the following:

The Rome Statute of the International Criminal Court¹² stipulates:

 Article 8(b)(xxvi) considers the conscription or enlisting of children into the armed forces a <u>war</u> crime.

The 1989 United Nations Convention on the Rights of the Child¹³ includes:

- Articles 28 and 29, which refer to the right of the child to an education.
- Article 36, which protects the child against all forms of exploitation.
- Article 38(2) prohibits children under the age of
 15 from directly engaging in hostilities.

The 2000 Optional Protocol on the Involvement of Children in Armed Conflict "exists to strive for the promotion and protection of the rights of the child."

 Article 1 prohibits the conscription of children under 18 into the armed forces.
