I trust that you will continue to extend your full cooperation to Ambassador Lopes and Ambassador Joyini.

I would like to thank you and congratulate you for the smooth consultations that we had this morning.

As requested by the Co-facilitators this morning, the Group has met to further discuss its reservation on OP1 -Op 4 and Op5 of the Draft Modalities resolution. The Group has thus come up with following the proposals on these paragraphs.

<u>OP1</u>

1. Decides that the high-level meeting of the General Assembly to commemorate the twentieth anniversary of the adoption of the Durban Declaration and Programme of Action will be held on Wednesday, 22 September 2021, and consist of an opening plenary meeting from 9 a.m. to 11 a.m., two consecutive round ene round tables from 11 a.m. to 1 p.m. and ene thematic panel from 3 p.m. to 5 p.m., and a closing plenary meeting from 6 p.m. to 7 p.m., and also decides that the morning meeting of the general debate on that day will be held from 11 a.m. to 1 p.m. and that that arrangement does not constitute a precedent;

- 4. Decides that the organizational arrangements of the round tables will be as follows:
- (a) The round tables will address the overall theme of "Reparations, racial justice and equality for people of African descent";
- (b) The Each round table will be co-chaired by a two Head of State or Government to be invited appointed by the President of the General Assembly after consultations with regional groups the Member States;
- (c) In order to promote a substantive and constructive dialogue, participation in the each round table will include twenty-five Member States, observers, representatives of entities of the United Nations system and experts, as well as selected representatives of civil society organizations and non-governmental organizations that are actively engaged in the fight against racism, racial discrimination, xenophobia and related intolerance; to be invited by the President of General Assembly, in consultation with the regional groups and bearing in mind the level of representation and the equitable geographical representation with due regard for gender balance;
- d) Accredited delegates, observers and selected non-governmental organizations that are active in the field of racism, racial discrimination, xenophobia and related intolerance will be able to follow the proceedings of the round-table sessions in the overflow room;
- (e) The proceedings of the round tables shall be webcast;

Delete OP5.

I would like to highlight that after considering the answers provided by the Cofacilitators today regarding the format of the high level event, the Group is still of the view that the suggested format will not provide enough opportunity for all delegations to make a statement during this commemorative event. That is why, In order to allow more time for Members States and Observer States to participate fully in this event, while taking into account the difficulties of having a full fledged plenary commemorative event, The group requests that the modalities of the 10th anniversary be reconducted for this event.

The Group believes that having two round tables open for the participation of States and other stakeholders, will ensure a higher level of inclusivity that is lacking in the current format.

The Group kindly requests that the co-facilitators reflect these elements in the revised draft.
