### Fourth special session of the Human Rights Council

The Secretariat of the Human Rights Council presents its compliments to all Permanent Missions in Geneva, United Nations departments and bodies, specialized agencies, intergovernmental and non-governmental organizations and has the honour to inform them that the Secretariat has received today at 1.00 pm a request addressed to the President of the Human Rights Council by the Ambassador of Finland to convene a special session on "The human rights situation in Darfur".

The above-mentioned request reads as follows: "I hereby request, on behalf of the signatories listed in the enclosed document, that you convene, as provided by the General Assembly resolution 60/251, a special session of the Human Rights Council entitled "The human rights situation in Darfur" immediately after the 3<sup>rd</sup> session of the Human Rights Council, preferably on 12 December 2006".

In order for a special session to be convened, in conformity with operative paragraph 10 of General Assembly resolution 60/251, the support of one-third of the membership of the Council (16 members or more) is required. The above-mentioned request was signed by the following 29 Member States: Algeria, Brazil, Canada, Czech Republic, Cuba, Ecuador, Finland, France, Gabon, Germany, Ghana, Guatemala, Japan, Mauritius, Mexico, Morocco, Netherlands, Nigeria, Peru, Poland, Republic of Korea, Romania, South Africa, Switzerland, Tunisia, Ukraine, United Kingdom, Uruguay and Zambia.

After consultation with the President of the Human Rights Council, the Secretariat will inform shortly all Permanent Missions in Geneva, United Nations departments and bodies, specialized agencies, intergovernmental and non-governmental organizations of the date and location of the special session.
