<b>Human rights violation/s or abuses alleged to have occurred</b>

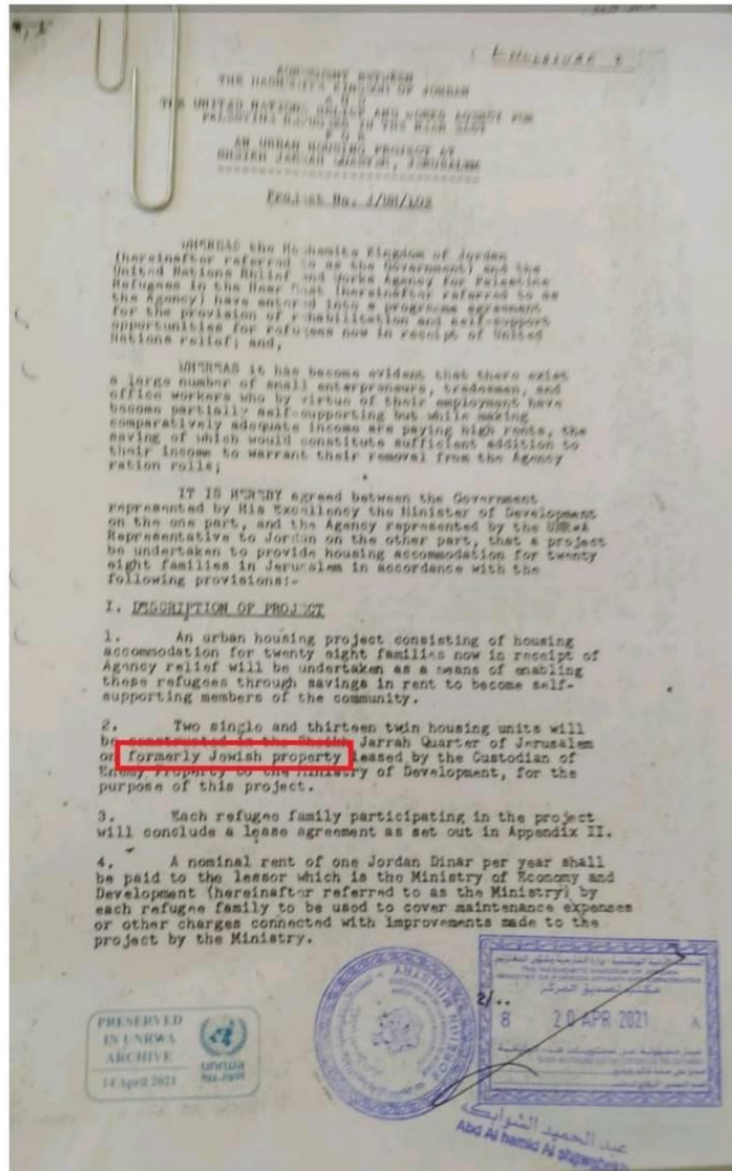
