	"sabotage al-Aqsa." The Iranian leader also said that "on the				
	issue of Palestine, all Muslim states and nations are				
	responsible, but the Palestinians themselves are the axis of Jihad."				

	At the same time, Hezbollah Secretary-General Hassan Nasrallah gave a long speech slamming Israel. He said that Israel is not ready for mass casualties. "Now, the Israelis are also fearful of a security conflagration with the Palestinians," he said. This was a coordinated message by Iran and its proxy terrorist groups (Hamas, Hezbollah) inflaming tensions around Jerusalem, weaving together conspiracies and calling for violence. They occurred as a coordinated message, and the message was not just about Quds Day. They were preparing the ground for further violence. Hamas flags were being brought to demonstrations in Jerusalem at the same time as the statements.
