## Non-governmental organizations

### **Report of the Committee on Non-Governmental Organizations on its 2017 resumed session**

**New York, 22-31 May and 12 June 2017**

#### *Summary*

At its 2017 resumed session, held from 22 to 31 May and on 12 June 2017, the Committee on Non-Governmental Organizations had before it 385 applications for consultative status, including 221 applications deferred from earlier sessions. Of the non-governmental organizations submitting those applications, the Committee recommended 191 for consultative status, deferred 162 for further consideration at its regular session in 2018 and closed without prejudice consideration of 30 applications of non-governmental organizations that had failed to respond to queries over two consecutive sessions of the Committee. The Committee deferred consideration of the three requests for reclassification of consultative status that were before it and of one request for a merger. The Committee considered five requests for a change of name, took note of four of those requests and deferred one. It also had before it 184 new quadrennial reports, of which it took note of 174. The Committee heard 20 representatives of the non-governmental organizations that attended the session.

The present report contains seven draft decisions on matters calling for action by the Economic and Social Council.

By draft decision I, the Council would:

- (a) Grant consultative status to 191 non-governmental organizations;
- (b) Note that the Committee decided to take note of the change of name of four non-governmental organizations;
- (c) Note that the Committee took note of the quadrennial reports of 196 non-governmental organizations, including new and deferred reports;

(d) Close without prejudice consideration of the request for consultative status made by 30 non-governmental organizations after the organizations had failed to respond to queries over the course of two consecutive sessions of the Committee;

(e) Note the withdrawal of applications by two non-governmental organizations.

By draft decision II, the Council would decide to withdraw the consultative status of the non-governmental organization International Chamber of Commerce, owing to a change in its status at the United Nations.

By draft decision III, the Council would suspend, for a period of one year, the consultative status of 128 organizations with outstanding quadrennial reports.

By draft decision IV, the Council would decide to reinstate the consultative status of 30 organizations that had submitted their outstanding quadrennial reports.

By draft decision V, the Council would decide to withdraw the consultative status of 128 organizations with continued outstanding quadrennial reports.

By draft decision VI, the Council would approve the provisional agenda for the 2018 session of the Committee.

By draft decision VII, the Council would take note of the present report.

### **Draft decision II**

#### **Withdrawal of the consultative status of the non-governmental organization International Chamber of Commerce**

The Economic and Social Council decides to withdraw consultative status with the Council of the non-governmental organization International Chamber of Commerce, pursuant to a request made by the organization, since it has been invited to participate at the General Assembly in the capacity of observer in accordance with General Assembly resolution [71/156](#) of 13 December 2016.

### **Draft decision III**

#### **Suspension of the consultative status of non-governmental organizations with outstanding quadrennial reports, pursuant to Council resolution 2008/4**

Having confirmed at its resumed session in May 2017 that the Secretariat had reminded non-governmental organizations with outstanding quadrennial reports of their reporting obligation and had advised them of the consequences of their further non-compliance after 1 May 2017, and that it had notified the permanent missions of the Member States in which the headquarters of such organizations are based of the final reminders, the Committee on Non-Governmental Organizations recommends to the Economic and Social Council the adoption of the following draft decision:

The Economic and Social Council decides, in accordance with its resolution 2008/4 of 21 July 2008, and recalling its decision 2016/236 of 25 July 2016, to withdraw immediately the consultative status of the 128 non-governmental organizations listed below, and requests the Secretary-General to advise the concerned organizations of this decision.

2. The Committee considered agenda items 3 (a), Applications for consultative status and requests for reclassification deferred from previous sessions of the Committee, and 3 (b), New applications for consultative status and new requests for reclassification, at its 18th to 29th meetings, held from 22 to 31 May 2017. It had before it the following documents:

#### **Inimõiguste Instituut**

6. At its 24th meeting, on 25 May 2017, the Committee considered the application of the non-governmental organization (NGO) Inimõiguste Instituut. The representative of the Russian Federation expressed his dissatisfaction with the organization's response to the question posed by the Committee on 7 February 2017 and reiterated his request to the organization to explain whether it found it possible to cooperate with people who had been accused of terrorism.

7. In taking the floor, the observer for Estonia stated that civil society and NGOs were vital partners in the work of the United Nations, not only in the policy deliberation processes but also in the execution of those policies. That being the case, it was imperative for the Committee to facilitate a more accessible, transparent and meaningful process in which NGOs could engage. In strongly supporting the activities of Inimõiguste Instituut (in English, the Estonian Institute of Human Rights), she highlighted the reputation of the organization as the first and oldest independent organization in Estonia that was focused on the protection of human rights in the country and around the world. As such, she regretted the deferment of the application once again and urged the Committee to recommend consultative status for the organization without delay.

#### **Mittetulendusühing Fenno-Ugria Asutus**

8. Also at its 24th meeting, the Committee considered the application of the non-governmental organization Mittetulendusühing Fenno-Ugria Asutus. The representative of the Russian Federation requested the organization to provide updated, detailed information regarding projects that it had implemented in 2016 and 2017 within the territory of the Russian Federation where the Fenno-Ugria people lived and that had been financed through grants from Estonia and other countries.

9. The observer for Estonia stated that the Committee should live up to its responsibility of making decisions on applications as quickly and effectively as possible based on whether the organization's activities met the criteria established in Economic and Social Council resolution 1996/31 and whether its aims and purposes were in conformity with the spirit, principles and aspirations of the Charter of the United Nations. She deplored the deviations from those guiding principles, whereby the consideration of organizations was subject to endless procedural measures or subverted to political agendas. She reiterated that Mittetulundusühing Fenno-Ugria Asutus was doing commendable work in preserving the Fenno-Ugric indigenous cultures and languages and should clearly be recommended for consultative status. Instead, she remarked, the organization's application had been pending since 2014, deferred for eight sessions for reasons that were unclear. She strongly urged the Committee to recommend granting consultative status to the organization.

10. The representative of the Russian Federation stated that, since there were over 80,000 Russian-speaking people in Estonia who were stateless, his delegation had requested the organization to explain how it protected the rights of those persons, but had yet to receive a response. He went on to say that his country had been carefully following the work of the organization, which seemed to have been using the issue of indigenous peoples to incite separatism. That was why his delegation felt that the organization did not deserve to be granted consultative status with the Council.

11. The representative of the United States of America stressed that it would be unfortunate to politicize the work of the organization, which was doing important work and whose application had been pending since 2014. She emphasized that the organization had already responded in 2014 to the same question posed to it by the Russian Federation, and therefore requested the delegation of the Russian Federation to withdraw its question.

12. The representative of the Russian Federation reiterated the need to pose the question because the organization did not meet the criteria for obtaining consultative status with the Council. The representative of the United States expressed concern that the representative of the Russian Federation seemed to have confused the two organizations with another, since the Committee was reviewing the organization that focused on the rights of the Fenno-Ugric people and preserving their culture and language, not any other people.

#### **Iran Human Rights Documentation Center**

13. At the 28th meeting, on 30 May, following a question posed by the representative of the Islamic Republic of Iran concerning the application of the Iran Human Rights Documentation Center, the representative of the United States took the floor to remind the Committee that the application from that organization had been pending since January 2010, having been blocked by several delegations for seven years, or 15 consecutive sessions, with over 60 questions posed to it about its funding and work, which it had answered dutifully. She emphasized that, despite the fact that many of the questions were repetitive or unreasonably detailed, the organization had nevertheless responded to each of them. For example, on several occasions, the organization had had to justify why it had chosen to focus on the human rights situation in the Islamic Republic of Iran, even though the Third Committee had repeatedly adopted resolutions concerning the human rights situation in that country. The Committee on Non-Governmental Organizations, she reiterated, was tasked with determining whether NGOs could contribute meaningfully to the work of the Council, and on the basis of that criteria, her delegation strongly supported the organization, stating that it merited accreditation to the Council. The representative of the United States stated that, on 17 January

2011, the Committee had asked the organization how it maintained its independence while receiving funding from governments. The organization answered that question on 28 January 2011. Even so, the Committee again asked it the same question on 2 February 2011, 27 May 2011, 7 February 2012, 6 February 2013, 2 February 2015 and 5 June 2015. The organization had been asked the same question numerous times since applying five years earlier. The Committee subjected very few NGOS to such intense levels of politically motivated scrutiny, the only ostensible purpose of which was to delay the organization's application indefinitely. She therefore requested the delegation of the Islamic Republic of Iran to review the responses received so far and to withdraw its questions.

14. In his response, the representative of the Islamic Republic of Iran stated that the case of the Iran Human Rights Documentation Center was one that demonstrated the validity of the Committee and its work. He cited the case as an example of the manipulation and abuse of NGO status, stating that it was an ostensible NGO created by a Government to act against another Government, could in no way be considered a non-governmental organization and did not deserve to have the status of one. He maintained that the case in question was an exploitation of NGO status for political purposes in order to interfere in the internal affairs of other countries, which was clearly against the Charter of United Nations and against resolution 1996/31. In reaction to the use of the term "block" by the representative of the United States, he said that his delegation understood why the United States delegation was trying to block the work of the Committee by posing many irrelevant questions and enquiries. He further stated that if anything was the business of the United States, it was not human rights and it was not interference in the internal affairs of other countries. He continued by saying that the Committee understood what was politically motivated and what was not, that the organization in question was a clear example of the politicization of human rights and NGOs and that his delegation would not accept any interference by the United States in the internal affairs of the Islamic Republic of Iran. He reiterated that his delegation did not think that human rights was an issue that the Government of the United States was particularly concerned about, as voiced many times recently by the President of the United States himself. He concluded by advising the United States to focus on its own concerns and priorities, as everyone knew what those were.

#### **Requests for reclassification**

15. At its 25th meeting, on 26 May, the Committee considered three deferred requests for reclassification of consultative status, as contained in conference room paper [E/C.2/2017/CRP.8](#). It decided to further defer its consideration of the applications for reclassification of status of the following organizations, pending the receipt of responses to questions posed by the Committee:

International Campaign to Ban Landmines

Universal Peace Federation

Widows for Peace through Democracy

#### **Applications closed without prejudice**

16. At its 29th meeting, on 31 May, the Committee decided to close without prejudice consideration of the applications of 30 non-governmental organizations that had not responded to the Committee's questions despite three reminders sent to the organizations (see chap. I, draft decision I, subpara. (e)).

## **B. New applications for consultative status and new requests for reclassification**

17. The Committee considered agenda item 3 (b), New applications for consultative status and new requests for reclassification, at its 18th to 20th meetings, held on 22 May and 23 May, and its 27th meeting, on 30 May. The Committee considered a total of 164 new applications for consultative status.

20. At its 20th meeting, on 23 May, the Committee considered a new request for reclassification from the International Federation of Consular Corps and



Associations, as contained in document [E/C.2/2017/R.3/Add.1](#). It decided to defer its consideration of the request pending the receipt of responses to questions posed by the Committee.

### **C. Other related matters**

#### **Requests for a change of name**

26. At its 27th meeting, on 30 May, the Committee considered four new requests for a change of name by organizations in consultative status, as contained in conference room paper [E/C.2/2017/CRP.12](#), and one request for a name change deferred from a previous session, as contained in conference room paper [E/C.2/2017/CRP.11](#). It decided to take note of the change of name of four organizations (see chap. I, draft decision I, subpara. (b)) and to defer its consideration of the request for a change of name by the following organization, pending the receipt of responses to questions posed by the Committee:

ZOA Vluchtelingenzorg (Special, 2012) to Stichting ZOA

#### **Request for withdrawal of consultative status**

27. At its 27th meeting, on 30 May, the Committee took note of the request for withdrawal of consultative status by one non-governmental organization (see chap. I, draft decision II).

## **IV. Strengthening of the Non-Governmental Organizations Branch of the Department of Economic and Social Affairs of the Secretariat**

28. At its 17th meeting on 22 May, the Committee jointly considered agenda item 5, Strengthening of the Non-Governmental Organizations Branch of the Department of Economic and Social Affairs of the Secretariat, and agenda item 8, General voluntary trust fund in support of the United Nations Non-Governmental Organizations Informal Regional Network, and heard oral reports made by the Secretariat.

29. The Acting Chief of the NGO Branch highlighted the lack of adequate resources to deliver on a steadily increasing volume of work, including the processing of applications and quadrennial reports from NGOs every year, as well as the related support for the Committee's paperless system. Particular urgency was

emphasized for the current session, given the fact that the workload of the Branch in 2017 far exceeded its capacity after temporary resources allocated by the Fifth Committee had been discontinued. Under the circumstances, a backlog in the submission of applications had appeared, leading to inordinate delays for NGOs in obtaining consultative status with the Council. The Committee was therefore urged to consider ways to support the Branch's efforts to enable it to fully meet its obligations under resolution 1996/31. As a means of coping with the increased workload, the presentation of quadrennial reports to the Committee as conference room papers allowed for quicker and more cost effective processing of the exponentially increasing number of these reports.

**V. Review of the methods of work of the Committee: implementation of Council resolution 1996/31, including the process of accreditation of representatives of non-governmental organizations, and Council decision 1995/304**

30. At the 17th meeting, on 22 May, under agenda item 2, Adoption of the agenda and other organizational matters, the representative of China requested the Secretariat to clarify the word "statements" in the work programme of the Committee, which he said had not appeared in past sessions, and questioned the need for its inclusion. The Secretariat explained that the term had been introduced in the regular session of the Committee in January 2017 because of requests for general statements from the floor by Member States and observer States at the opening of the session of the Committee.

31. The representative of the United States reminded the Committee that the word "statements" was included to clarify the specific agenda item under which general statements could be made, as there had previously been confusion about when statements, including those by Member States, should be made, leading to the adoption of the programme of work with the word "statements" at the last session. The representative of India confirmed that statement, but maintained that, as far as NGOs were concerned, they were allotted a particular time slot during the question-and-answer session at the end of each day to make their statements, referring to NGOs that had submitted their applications for obtaining consultative status. He added that while he was happy to see the word "statements" included, it nevertheless needed further discussions about the nature of the statements, the particular topics, the list of speakers, and other details.

32. The representative of Greece said that he welcomed the explicit addition of the word "statements" in the agenda, which was compatible with past practice, and that it made sense for members of the Committee, observer States and civil society to make general statements at the beginning of the session.

33. The representative of China reiterated that the inclusion of the word was not necessary and, if it were to be included at all, it should be clarified that it referred to statements from Member States only. The representative of the Bolivarian Republic of Venezuela also requested clarification as to who should deliver the statements, in order to avoid any confusion or misinterpretation.

34. Following those statements, the Chair of the Committee gavelled the discussion on the programme of work to a close and suggested that members of the Committee take up the issue informally, to which the representative of China objected, saying that since there was a pending question, the agenda could not be adopted. In support of the representative of China, the representative of the Russian

Federation stated that the Chair should not have adopted the agenda without objections, because there had been objections. The Chair explained that, in his view, there was no substantive difference whether the word “statement” was included or not.

35. The representative of China reiterated that his delegation had no objections to statements from Member and observer States and proposed amending the wording to “statements from Member States and observer States”, to which the representative of the Islamic Republic of Iran agreed. The representative of the United States objected to the wording and stated that, since the agenda had already been approved, it was necessary to continue with the programme of work. The representative of Greece also expressed his support for the programme of work as it had been gavelled.

36. The representative of Cuba suggested that the Chair should allow more time before gaveling in order to avoid rushing through the programme of work and to allow the interpreters sufficient time to translate his words. He agreed to the inclusion of the word “statements” with the understanding that it would refer only to Member and observer States, as had been the practice of the Committee, namely, to allow general statements at the opening session of the Committee and specific statements when a specific application was under review, while allowing NGOs to make their statements only at the question-and-answer session held every day.

37. The representative of the Russian Federation proposed that the current programme of work be adopted, but on the condition that consideration of the issue of including the word “statements” be postponed to 30 May, after discussions during informal consultations.

38. The representative of China maintained, however, that, while his delegation did not want to challenge the Chair’s gavel, the gaveling had taken place after his delegation had requested the floor, and his delegation was not able to accept the working paper as it was currently formulated.

39. The representative of the United States sought to clarify that the question-and-answer session held between 5 and 6 p.m. was not allotted for statements by NGOs in consultative status, but for NGO applicants hoping for accreditation. The representative of Greece supported the position of the United States, adding that there was no provision for NGOs to make general statements during the question-and-answer slot, which were made only at the opening session.

40. In agreeing with the request of China, Cuba and the Russian Federation for additional time to discuss the issue, the representative of Israel also declined to challenge the Chair’s gaveling. The representative of the Bolivarian Republic of Venezuela pointed out that members seemed to be interpreting the issue in different ways, which was why it needed to be clarified right away in order to avoid future discussions.

41. The representative of China stated that his delegation could accept the agenda and proceed to the next agenda item, provided that the programme of work would be reconsidered on 30 May.

42. At that point, the representative of the United States asked the representative of China to clarify his reasons for not allowing NGOs to make general statements, citing the case of an NGO that had spoken for four minutes on behalf of 230 organizations at the resumed session in 2016. The Chair sought to clarify that any Member State could cede the floor to civil society to speak, which was why it did not matter whether the wording “statements by member and observer States” was specifically inserted in the programme of work. He then proposed adopting the current version of the programme of work by deleting the word “statement” from it,

to which the representative of the United States responded that, as Member States were able to make statements, with or without the word “statement” in the working paper, her delegation could go along with the amendment. The Committee then adopted the programme of work.

43. In concluding the discussions on subsequent agenda items, the Chair asked whether delegations had any statements to make, to which the representative of Uruguay requested to cede her delegation’s place to an NGO. The representative of China then asked under which agenda item the organization would be making the statement. On being informed that it was under item 6 (c), Other related matters, his delegation raised an objection and asked the representative of Uruguay to explain why she was requesting that the organization make a statement under that item.

44. In response, the Chair asked the delegation of China to clarify whether it was negating the right of Uruguay to give the floor to civil society, to which the representative of China responded that he would like to request the opinion of the legal adviser on the matter.

45. The delegation of the United States enquired as to the reason for preventing the organization from making a statement, reiterating that she would like to hear from it, unless it was a matter of a point of order. The Chair clarified that a request for a legal opinion had been made by China but that the request needed to be made on behalf of the entire Committee, and not by one Member State.

46. The representatives of India and the Russian Federation requested the representative of Uruguay to clarify whether the NGO in question was part of the Uruguayan delegation. In response, the representative of Uruguay cited the precedent set in May 2016, when a Member State had ceded its right to a civil society organization to make a statement from the floor of the Committee.

47. The representative of Uruguay reiterated that her delegation’s request did not contravene any rule of the Committee. The representative of India reminded the Committee that that was not the first time that Member States had engaged in discussing the issue. However, he pointed to paragraph 32 of Council resolution 1996/31, which provided that NGOs in consultative status might be given the opportunity to make statements. In view of that provision, he suggested that his delegation would be happy to join consensus on a proposal for making a list of NGOs and other non-State actors wishing to make statements, to be circulated prior to the session, with the relevant agenda item specified so that it could be presented for consideration.

48. The representative of Greece stated that there was no prohibition against NGOs taking the floor and questioned the grounds on which the delegation of Uruguay was being prevented from giving up its speaking slot to a member of civil society, once again reiterating his delegation’s support for the organization to take the floor, in keeping with the practice at the 2016 resumed session. The representative of the United States highlighted the fact that the role of the Committee was to promote the engagement of NGOs, which included hearing from NGOs, and since there was no point of order, she once again requested the representative of China to explain why he was concerned about allowing the organization to speak before the Committee.

49. The representative of the Russian Federation expressed his support for the statements made by China and stated that, while his delegation was in favour of allowing civil society to speak in any Committee, he was not aware of any practice whereby a Member State could cede the floor to a civil society organization. Instead, he suggested that, if the organization was in consultative status, it could



distribute its statement or the delegation of Uruguay could deliver the statement on its behalf.

50. The representative of China reiterated his call for the opinion of the legal adviser on the matter and expressed the view that “no prohibition” in the rules of procedure regarding a Member State ceding its right to speak to civil society did not mean “permission” to do so, while the representative of the Russian Federation maintained that his delegation would support the right of civil society to speak only if it was in accordance with the rules of procedure.

51. The representative of Uruguay then stated that, since China and the Russian Federation objected to her country’s ceding its place to an NGO, she would call for a vote.

52. Following these statements, a roll-call vote was requested by Uruguay, in accordance with rule 59 of the rules of procedure of the Economic and Social Council, to allow it to cede its right to Amnesty International to make a statement at that time. On a point of order, the representative of the United States requested clarification of what was being voted on, and stated that she was concerned that the delegations were hiding behind semantics on the vote. She therefore proposed two separate votes, to move beyond the semantics of ceding the floor versus whether a member of civil society could speak: the first vote to determine whether the delegation of Uruguay would be allowed to cede the floor to the civil society organization to speak and the second vote on whether the civil society organization could speak then.

53. Before the vote, the representative of the Islamic Republic of Iran reminded the Committee of its mandate and its workload, saying that the mandate should not go beyond the granting of consultative status to NGOs. In his delegation’s view, it was the prerogative of every Member State to give its speaking slot to anyone as a representative, provided that that representative was part of the delegation of that country, sitting behind the nameplate of that country. Since that was not the case in the instance in question, his delegation would be voting against the proposal.

54. The representative of the United States underlined that it was extremely important for the Committee on Non-Governmental Organizations to hear from civil society, since it was the mandate of the Committee to accredit civil society to speak within the United Nations and to facilitate its participation through that formal process. That was why her delegation wished to encourage other Committee members to vote for allowing a member of civil society to speak.

55. The representative of India explained that his delegation believed in the right of anyone to designate any person as a member of his or her delegation and to authorize him or her to speak on behalf of the delegation. However, in the case in question, a member of an intergovernmental body was asking to authorize a non-member civil society organization to speak, which was venturing into uncharted territory. He emphasized that his delegation had been requesting that the matter be discussed further in order to arrive at a consensus rather than proceed in a rushed manner. He believed that, while no member of the Committee had a right to cede its right to speak, his delegation would have been amenable if the floor had been given to a member of the delegation of that member’s seat to make the statement. He added that his delegation could not accept ceding the floor to someone who was not a part of the delegation, which was why he would vote against the proposal.

56. The representative of Greece expressed his delegation’s support for the right of Amnesty International to take the floor to make a statement, as Uruguay had requested, stating that hearing an NGO make a statement added value to the work of the Committee. He went on to say that, as had already been clarified, there was no

provision prohibiting an NGO from making a statement during the opening session of the Committee, especially when a member had requested it, which was why his delegation would vote in favour of the request of Uruguay and encouraged all the delegations to do the same.

57. The proposal to allow Uruguay to cede its right to Amnesty International to speak then under rule 59 of the rules of procedure was rejected by a roll-call vote of 14 to 4. Of the 19 members of the Committee, 18 were present and voting. The voting was as follows:

*In favour:*

Greece, Israel, United States, Uruguay

*Against:*

Azerbaijan, Burundi, China, Cuba, India, Iran (Islamic Republic of), Mauritania, Nicaragua, Pakistan, Russian Federation, South Africa, Sudan, Turkey, Venezuela (Bolivarian Republic of)

*Absent:*

Guinea

58. Following the vote, the representative of the Russian Federation thanked everyone who voted against the proposal because, he said, it would have undermined everything that the Committee had built up over the decades, emphasizing that no country was against civil society but that his delegation objected to being manipulated by means that were far removed from the interests of civil society. He added that, while the organization in question, Amnesty International, had a decent reputation, what had transpired that day at the Committee reflected negatively on the organization.

59. After the vote, the representative of Turkey stated that her country attached importance to the participation of civil society in the work of the United Nations and its bodies, including the NGO Committee, and that her delegation did not consider the vote as a vote on the participation of civil society at the United Nations or in the Committee. She clarified, however, that the discussion prior to the vote, as well as most of the explanations of the vote, indicated that more consultation was necessary, since it was a new matter, not only from a substantive point of view but also from the perspective of the rules of procedure and of working methods and practices, including of the Committee.

60. At the 18th meeting, on 22 May, the representative of the United States stated that she would prefer not to have to call another vote and again asked the Committee members to allow the organization to speak, as had previously been done during the May 2016 session, after long and intensive discussions. When China and the Russian Federation objected, the United States called for a vote to allow a Council-accredited NGO to speak then, under agenda item 6 (c).

61. In response to the request by the United States, the representative of the Russian Federation requested a no-action motion on the proposal, in accordance with rule 50 of the Council's rules of procedure.

62. The Secretariat explained to the Committee that a motion for adjournment of debate under rule 50 of the Council's rules of procedure could be called by a Committee member at any time on the item under discussion and that permission to speak on the motion would be accorded only to two representatives favouring and to two opposing the adjournment, without any explanation of the vote, after which the motion would be put to the vote immediately.

63. The representative of China stated that his delegation supported the motion put forth by the Russian Federation.

64. The representative of Greece stated that, as a matter of principle, his delegation objected to a no-action motion because it did not facilitate substantive discussions and did not help the work of the Committee. In agreeing with Greece, the representative of the United States stated that her vote had been called in order to engage in a substantive discussion, whereas a call for a no-action motion on the debate was designed to stop the substantive discussion. She reminded the Committee that there was already a precedent allowing the floor to be ceded to a member of civil society to speak and that a no-action motion would be going back on that precedent.

65. The representative of the Russian Federation explained that, while his delegation was in favour of civil society participation in the Committee, he was categorically opposed to civil society being used by some countries to further their political interests and there should be a consensus decision on the matter that satisfied all members of the committee.

66. The Chair then explained that a vote in favour of the motion to adjourn the debate would mean rejecting the proposal by the representative of the United States, while a vote against the motion would mean that the proposal would remain before the Committee and that the Committee would proceed to take action on it afterwards.

67. The no-action motion to adjourn the debate under rule 50 of the rules of procedure was adopted by a roll-call vote of 13 to 4, with 1 abstention. Of the 19 members of the Committee, 18 were present and voting. The voting was as follows:

*In favour:*

Azerbaijan, Burundi, China, Cuba, India, Iran (Islamic Republic of), Mauritania, Nicaragua, Pakistan, Russian Federation, South Africa, Sudan, Venezuela (Bolivarian Republic of)

*Against:*

Greece, Israel, United States of America, Uruguay

*Abstaining:*

Turkey

*Absent:*

Guinea

68. At the conclusion of the vote, the observer for Mexico took the floor to state that his delegation was distressed by the procedure that had just taken place because it violated rule 62 of the rules of procedure, which stated that a delegation that submitted a motion could not speak in support of it. Moreover, he stated that the vote ran counter to the spirit of the United Nations and that his delegation hoped it did not constitute a precedent.

69. The representative of the Bolivarian Republic of Venezuela explained that her delegation supported the motion because she felt that consultations among Committee members were necessary in order to reach consensus on its working methods before establishing precedents. The representative of the Russian Federation echoed the words of the representative of the Bolivarian Republic of Venezuela and advocated the need to reach an understanding on the challenging and sensitive issue of allowing civil society organizations to speak to the Committee. He elaborated on the need to develop principles and criteria for their participation.

70. The representative of India maintained that his delegation viewed civil society as an important partner of the United Nations. However, he expressed concern about the manner in which decisions were being precipitated regarding the working

methods of the Committee, without prior consultation and without considering the long-term implications of those decisions. The representative of China concurred with that statement, maintaining that decisions by the Committee should be made by consensus and should avoid calling for votes.

71. At the 29th meeting, on 31 May, the representative of Cuba emphasized the need for formal discussions on item 6, pertaining to the methods of work of the Committee during its sessions. The Chair stressed the need to accelerate the work of the Committee and to allow for time to engage in such discussions. He suggested informal discussions on the matter at a later date, prior to the 2018 regular session of the Committee.

#### **Statements by non-governmental organizations at the 2017 session of the Council**

72. At its 17th meeting, held on 22 May, the Committee took note of the requests submitted by nine non-governmental organizations in consultative status to be heard by the Council at its 2017 session, as contained in conference room paper [E/C.2/2017/CRP.16](#), as follows:

#### **Statements by non-member States of the Committee**

73. At the 17th meeting, on 22 May, the observer for the European Union made a statement regarding the indispensable contribution of members of civil society to the work of the United Nations, from policymaking to their readiness to “speak truth to power”, which he cited as critical to the health of democracy and decision-making. He stated that the diversity of the organizations to be considered for accreditation was a testimony to their vital role, which made the duties exercised by members of the NGO Committee of considerable importance and interest to States Members of the United Nations, observers and the wider world. He further stated that the European Union and its member States strongly supported all efforts to make the work of the Committee fairer and more transparent and welcomed the decision by the Economic and Social Council in April to webcast the proceedings of the Committee. He stressed the importance of fairness in the proceedings of the Committee, based on Council resolution 1996/31, and urged the Committee to avoid the repeated deferment of applications on unjust grounds to bolster the credibility of its deliberations and decisions.

74. The observer for Austria stated that the Committee was a crucial body for NGO participation in the work of the United Nations and that it was therefore important for civil society representatives to address the Committee. To that end, the observer expressed his delegation’s appreciation of the efforts made by the delegation of Uruguay to support civil society.

75. The observer for Chile highlighted the recent initiative taken by his country, with the support of Mexico and Uruguay, to draft a decision at the Council in April to webcast the proceedings of the Committee. He explained that the move was designed to help to improve the working methods of the Committee and to make the work of the United Nations more accessible to civil society. He affirmed his country's belief that the participation of NGOs in United Nations processes was essential for the work of the Organization and that the 2030 Agenda for Sustainable Development relied heavily on the support and partnership of NGOs for their effective implementation. To that end, he pointed to the unique position occupied by the Committee in facilitating and encouraging NGO participation, which was why, he said, it was necessary to inject greater transparency and accountability into its proceedings. He expressed hope that, henceforth, the webcasts would make the sessions accessible to all applicants and enable NGOs, especially those from developing countries, to follow the proceedings and observe the decision-making process from all corners of the world.

76. The observer for the United Kingdom of Great Britain and Northern Ireland stated that his country's position was fully aligned with the statement made by the observer for the European Union. He, too, welcomed the Council decision taken in April to webcast all public meetings of the Committee and hoped that that modest step would help to facilitate the participation of NGOs from around the globe, particularly for those who could not afford to come to New York to observe the proceedings. He stated that the United Kingdom placed great importance on the protection of civil society space at the United Nations, enabling NGOs to bring their expertise, new ideas and valuable perspectives to the development agenda. He further stated that his country felt the clear need for the Council to have a body to review the large volume of applications received from NGOs for consultative status but that it should be one that did so with the clear goal of facilitating greater NGO access to the United Nations and its work, not restricting it. He emphasized the need for the Committee to embody the principles of non-discrimination, equality, participation, transparency and accountability, as embodied in resolution 1996/31, but which, he said, were not always reflected in the actions of the Committee. He expressed particular concern about applications that languished in the Committee for years, while others were rejected by the body without good cause, necessitating the reversal of some decisions by the Council. He highlighted in particular the high rate of deferral of applications from NGOs that work in human rights, which he said was of great concern, since human rights was one of the fundamental pillars of the United Nations, and the granting of consultative status to those NGOs was vital to the credibility of the Committee.

## **VI. Consideration of special reports and complaints by Member States**

77. There were no special reports for the Committee's consideration at the session.

## **VII. Provisional agenda and documentation of the 2018 session of the Committee**

78. At its 29th meeting, on 31 May, the Committee considered agenda item 9, Provisional agenda and documentation for the 2018 session of the Committee, and had before it the draft provisional agenda for its 2018 session ([E/C.2/2017/L.1](#)).

79. At the same meeting, the Committee decided to recommend to the Council the following dates for the sessions in 2018: from 29 January to 7 February and on

23 February for its 2018 regular session, and from 21 to 31 May and on 11 June for its 2018 resumed session.

## **VIII. Organization of the session**

### **A. Opening and duration of the session**

80. The Committee on Non-Governmental Organizations held its 2017 resumed session from 22 to 31 May and on 12 June. The Committee held 14 meetings.

### **B. Attendance**

81. The session was attended by all 19 members of the Committee. Observers for other States Members of the United Nations, observers for non-member States and representatives of organizations of the United Nations system and of non-governmental organizations also attended. The list of participants will be issued in document [E/C.2/2017/INF/2](#).

82. At its 2017 resumed session, the Committee heard 20 representatives of non-governmental organizations, who were given the opportunity to respond to questions raised by the Committee. The additional information provided by the representatives facilitated the debate and the work of the Committee in taking its decisions.

### **C. Election of officers**

83. At its 17th meeting, on 22 May, the Committee elected Mr. Hassan Idriss Ahmed Salih (Sudan) as Vice-Chair of the Committee.

### **D. Agenda**

84. The agenda ([E/C.2/2017/1](#)) for the 2017 regular and resumed sessions reads as follows:

7. Consideration of special reports.
8. General voluntary trust fund in support of the United Nations Non-Governmental Organizations Informal Regional Network.
9. Provisional agenda and documentation for the 2018 session of the Committee.
10. Adoption of the report of the Committee.
